### 3. HAZARDS IDENTIFICATION:

Extremely flammable.

DANGEROUS GOODS: NON HAZARDOUS SUBSTANCE.

### 4. FIRST AID MEASURES:

**INHALATION:** Move the exposed person to fresh air at once. Provide rest, warmth and fresh air.

**INGESTION:** Not relevant.

**SKIN:** Wash the skin immediately with soap and water. Get medical attention if any discomfort continues.

**EYES:** Make sure to remove any contact lenses from the eyes before rinsing. Promptly wash eyes with plenty of water while lifting the eye lids. Continue to rinse for at least 15 minutes. Get medical attention if any discomfort continues.

### 5. FIRE FIGHTING MEASURES:

**EXTINGUISHING MEDIA:** Use: Powder. Dry chemicals, sand, dolomite etc. Water spray, fog or mist.

**SPECIAL FIRE FIGHTING PROCEDURES:** Containers close to fire should be removed or cooled with water. Use water to keep fire exposed containers cool and disperse vapours.

**USAGE PRECAUTIONS:** Keep away from heat, sparks and open flame. Avoid spilling, skin and eye contact. Ventilate well, avoid breathing vapours. Use approved respirator if air contamination is above accepted level.

**STORAGE PRECAUTIONS:** Aerosol cans: Must not be exposed for direct sunlight or temperatures above 50°C.
